### VENUE RENTAL

Ceremony and Reception Venue pricing is based on the number of guests attending the wedding and reception. The venue is booked for a five-hour event ending no later than 10pm. An additional hour can be added for \$900/hour, ending no later than 10pm.

Included in the venue cost are white wedding chairs for the ceremony and reception, reception tables, linen tablecloths and napkins, china, glassware, flatware and servers through the reception.

The setup beforehand, service throughout the event and cleanup after the reception is taken care of by our Wedding Coordinator and team.

## CATERING & ALCOHOL

---

### WEDDING RECEPTION DINNER

Mountain Springs Lodge requires that a caterer be booked to provide the wedding reception meal. We refer many fantastic local caterers to cater your dining needs through your time here.

If your caterer would like use of Mountain Springs Lodge Commercial Kitchen, a Use Fee of \$200 will be charged to the wedding party. The caterer must provide proof of insurance & list Mountain Springs Lodge as additionally insured 30 days prior to the wedding.

### ADDITIONAL MEAL – REHEARSAL DINNER OR BRUNCH

If you would like to host a rehearsal dinner or group brunch during your stay with us, you are able to select the venue of your choice for up to two hours.

Mountain Springs Lodge will provide tables, chairs, linens, linen napkins, glassware, flatware, china, bussing staff, bartenders as well as setup and cleanup of the items provided.

Beer, Wine and Champagne must be purchased and served through Mountain Springs Lodge licensed staff.

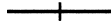
For an additional meal, such as a Rehearsal Dinner or Group Brunch, the following charges apply:

up to 50 guests	\$1,500
up to 100 guests	\$2,500
up to 150 guests	\$3,500
up to 200 guests	\$4,500

If you would prefer a non-staffed rehearsal dinner or brunch, the event must meet the following criteria:

- The event must be held at a lodge your party has booked
  - Ponderosa Lodge – up to 50 indoor / up to 200 outdoor
  - Pines Lodge – up to 25 indoor / up to 50 outdoor
  - Trailhead Lodge – up to 16 indoor / up to 50 outdoor
- Day guests attending this event and not lodging at Mountain Springs Lodge are assessed at \$25/person. Please advise us of planned guests so we can assure the capacity of parking.
- All outdoor noise and music must end by 10pm
- Mountain Springs Lodge will provide, if desired, tables and chairs (\$10/table & \$3/chair) for your event.

## BEVERAGE POLICIES



A fine selection of wines, champagnes & beers are available for your event through Mountain Springs Lodge. For a current list of beverages and pricing, please request the Mountain Springs Lodge Banquet Beverage List. Below are the policies clarifying the position of Mountain Springs Lodge on the serving of alcoholic beverages.

- \_\_\_\_\_ All alcohol served must be purchased through Mountain Springs Lodge. If the host prefers to provide their own beer, wine or champagne, a corkage fee of \$15 per 750 ml bottle of wine or champagne, \$150 per half-barrel keg and \$75 per pony keg will be applied to all bottles of wine or cases of beer opened.
- \_\_\_\_\_ Mountain Springs Lodge shall provide a qualified server who is licensed and certified by The State of Washington, to serve alcoholic beverages at the event. All alcohol must be served through the provided bartenders. If alcohol is brought into the reception by a guest, it will be confiscated, and the bar may close for the remainder of the event.
- \_\_\_\_\_ Mountain Springs Lodge adheres to all Washington State Liquor & Cannabis Board regulations. MSL qualified servers will not serve any guest under 21 years and will require ID of any person looking under 30 years old before serving. Bartenders will not overserve a guest.
- \_\_\_\_\_ According to Washington State Liquor & Cannabis Board regulations, no person is permitted to engage in the consumption of marijuana on Mountain Springs Lodge property.
- \_\_\_\_\_ Hard liquor is not permitted at events that occur at Mountain Springs Lodge. Kegs may be allowed on a case-by-case basis. If a keg is permitted and there is any beer remaining in the keg at the end of the reception, it is not allowed to be taken by the wedding party.
- \_\_\_\_\_ Consumption of alcohol is restricted by state law to buildings that have been privately reserved. Guests are not permitted to carry open containers of alcohol on grounds between lodges & venues nor to the pool area.
- \_\_\_\_\_ For any non-MSL sponsored gathering where there will be alcohol provided, the host is required to purchase and post a Washington State Banquet Permit for the duration of that event.
- \_\_\_\_\_ An 18% gratuity is assessed for a beverage service.
- \_\_\_\_\_ Payment for alcohol is due upon receipt of the invoice or prior to checkout.
- \_\_\_\_\_ Mountain Springs Lodge strongly urges that the host organize the use of designated drivers for the event. The host is responsible for arranging shuttle service if designated drivers are not available for guests who have over-consumed.
- \_\_\_\_\_ Upon signing of this Beverage Policy Contract, the hosting couple &/or family takes responsibility for the liability of serving alcoholic beverages and takes full responsibility for accidents that result from the serving of those alcoholic beverages. The host couple or family agrees to indemnify and hold harmless Mountain Springs Lodge from any and all liability or claims that relate to or result from their serving of alcoholic beverages at Mountain Springs Lodge.

# EVENT POLICIES

---

Mountain Springs Lodge appreciates your business and will make every effort to assure the success of your event. Adherence to the following policies and procedures is important as you plan your event.

## LODGING

A lodging minimum of two nights stay is required on weekends and three nights stay on select holidays.

Each lodging unit base rate includes a certain number of guests. Each additional adult over the base rate is \$35/adult and \$20/child (ages 2-12) per night.

Overnight guests may check in at 4:00 PM. Check out is 11:00 AM.

There may be a fee associated with early check in or late check out in the event that Mountain Springs Lodge is able to accommodate such a request.

## GUARANTEE

A final guarantee for the attendance and beverages ordered is due no later than fourteen business days prior to the scheduled function. Guarantees are not subject to reduction. If no number is given, the number on the original contract will be used as the final guarantee.

Financial responsibility will be for the guaranteed or the actual number of guests served, whichever is greater.

It is the event organizers responsibility to provide a list of guests and bed arrangements for the lodges in use fourteen days prior to your event. If no such list is received, the beds will be made according to Mountain Springs Lodge's standard arrangement. Last minute changes will incur a housekeeping fee of \$30 per bed change.

## DEPOSITS

A deposit, due at the time of booking, is required for all lodging and event space reservations.

The deposit required to reserve a facility or venue for a group event is half of the venue cost.

The deposit required to reserve the Ponderosa, Pines or Trailhead Lodges is the base rate plus tax for each day of use.

The deposit required to reserve a cabin, suite, house, or guest room is one-half of the base rate plus tax for all days of use.

## CANCELLATION POLICY

In the event of cancellation, deposits for the Ponderosa, Pines or Trailhead Lodges and wedding venues are nonrefundable unless the lodge or venues rebook to another party for the same time period. All refunds are subject to a 10% cancellation fee.

Deposits on all other cabins, suites, houses or guest rooms will be refunded only if notice of cancellation is given 30 or more days prior to the reservation arrival date. All refunds are subject to a 10% cancellation fee.

Cancellation made for beverages within fourteen days of the event will result in the full amount being charged.

Base Rates will be charged in full for all dates reserved should the contracting party depart before the end of the reservation.

## BEVERAGES & FUNCTIONS

Alcohol is restricted to beer, wine and champagne and must be provided through Mountain Springs Lodge, or if the host wishes to supply their own alcohol, a corkage fee will be applied. Mountain Springs Lodge will provide a certified server and under no circumstances will a minor under the age of 21 years be allowed to consume alcohol.

An 18% gratuity will be applied to all beverage services.

A 15% Service Fee that is distributed to staff involved in the venue preparation and maintenance will be applied to the venue. 100% of the pre-sales tax and payroll tax gratuity and service fee is distributed to the service staff involved with your event.

Music must conform to reasonable noise levels as determined by Mountain Springs Lodge and must be quiet by 10:00 PM.

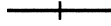
**Wedding ceremony & reception facility rental charge is for a period of five hours of event time** unless other arrangements are made in advance and included on the contract. One additional hour may be added for \$900, ending no later than 10pm.

For winter ceremonies (December – February), the earliest Saturday ceremony time is 4pm due to parking availability.

If you would like to guarantee event exclusivity for your group this must be prearranged, all onsite lodging must be booked by your group, and an exclusivity fee of \$1,200 will be applied to ensure that no other onsite event will take place the day of your wedding. Exclusivity does not pertain to Mountain Springs Lodge activities such as Zipline Tours, Horseback Rides, Sleigh Rides or Snowmobile Tours.

Additional fees may be charged if additional service, set-up, and cleanup is requested and approved by the facilitator of the group. These fees will be added to the final bill.

## EVENT POLICIES (CONTINUED)



### OTHER

Mountain Springs Lodge will accept wedding bookings up to 18 months prior to the wedding date.

Storage: While Mountain Springs Lodge is able to provide refrigerated space for the wedding cake & desserts, our space is limited, and we are not able to provide flower refrigerator storage. We recommend arranging same-day delivery with your florist.

Pets are only permitted in certain cabins at \$25/day. If outdoors, pets must be on-leash at all times. Those in charge of scheduling the event are solely responsible for communicating this policy to dog/pet owners. If the animal enters a non-pet friendly building, there will be an additional fee of \$600.00 charged to the event organizer for the cost of the intense cleaning that must take place.

Quiet hours are between 10:00 PM and 8:00 AM.

Mountain Springs Lodge has a strict non-smoking policy. Absolutely no smoking is permitted inside any building. Smoking is permitted on front decks of buildings and the ash receptacles must be used. If smoking is detected inside there will be an additional cleaning fee of \$300.00 plus additional charges for damage or repair fees charged to the event coordinator.

Day guests not lodging at Mountain Springs Lodge that attend an event not sponsored by Mountain Springs Lodge will be charged \$25.00 per person. Please advise us of planned guests so we can assure the capacity of your lodging and parking.

Dancing on interior wooden floors is not permitted. A dance floor may be rented and placed on top of the flooring or outside on the lawn. (The Beaver Creek Barn provides a built-in dance floor and does not require that an additional dance floor be rented).

### TENT CAMPING

A limited number of tents will be permitted at designated locations with prior approval by the Wedding Coordinator. Occupants of tents will be charged \$25/person per night.

### DAMAGE/DECOR

We ask that the venues be left as they were found. It is the Lodge's discretion to charge labor for cleanup of trash and décor remaining at the end of the event.

Mountain Springs Lodge does not permit décor of confetti, glitter, fake petals and open flame candles in any indoor or outdoor venue. If these items are used, an additional \$500 fee will be applied.

The contracting party will be responsible for all damages to the buildings, furnishings and property including but not limited to doors, windows, stereo equipment, carpets, linens, towels etc. If excessive cleaning is required, a cleaning charge of \$40/hour will be applied.

### BILLING AND PAYMENT

All charges are subject to state sales tax, a 15% service fee will be added to the Venues and an 18% gratuity will be added to beverages and group activities.

The contracting party is responsible for payment of the bill upon receipt of the invoice or prior to checkout.

Accounts over thirty days old will be charged a finance fee of one and one-half percent per month or the maximum allowed by law. If collection procedures become necessary, you will be responsible for costs and reasonable attorney fees.
