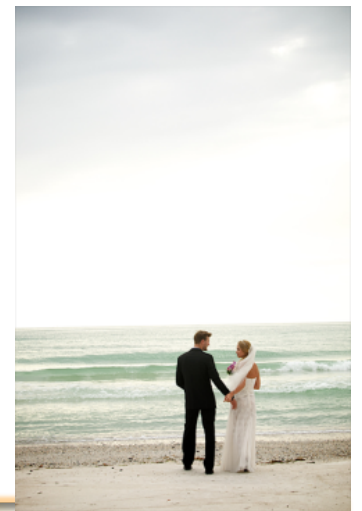

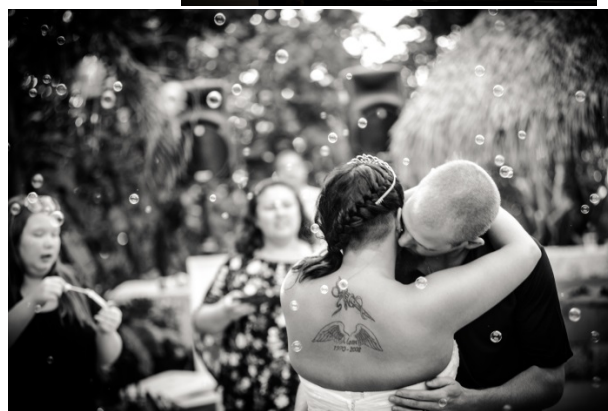
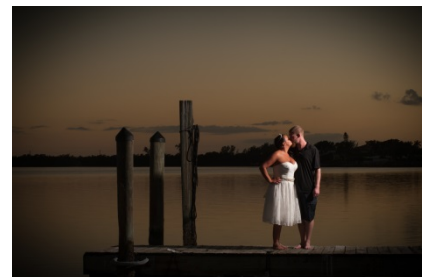

## **Service Agreement**

This agreement is between the undersigned and Sand Petal Weddings. We hereby agree to the following terms and conditions. See attached proposal for purchase description.

### Terms & Conditions:

Ceremony/wedding location: SPW works with several locations on several beaches (both public & private) that we approve as sites where we can perform your wedding. If a bride would like to choose a location for her ceremony/wedding that we have never been too and is not one of our designated locations, SPW will need to approve the site first. The things we take into consideration when approving a site is whether we can access the beach easily, is there parking for vehicles including the many vendor vehicles, and how far of a walk it is when carrying chairs & all the cumbersome wedding decor to an unfamiliar beach location. SPW must approve the site first before we will agree to perform the ceremony there. If SPW does approve a difficult site, there may be extra charges for needing additional set-up crew and close easily accessible parking has to be guaranteed for the vendors provided in your package. Our Beach Ceremonies & our 'Cake & Champagne' reception package can be performed at the public beach. Public beach permits start at \$150 + per hour. Public beach events are done at specific wedding zones given by the county. Please note that due to the beach goers who mainly occupy the beach near the water, these zones are not close to the ocean in order to keep your event a little bit more private, but still have water background. If you wish your event to be near or closer to the water, then a private beach front property should be considered (there will be room requirements and the water proximity to the event will depend on the property lines). Our Basic Tented events can only be held at private locations. SPW will supply a list of several locations where our Basic Tented events can be performed. These locations will have room rental requirements and a possible site fee. Not all resorts require site fees however, and most generally only require room rentals. The Public beach is not an option with our Sand Castle nor is it an option with the Chickee Hut package as the Chickee Hut is a permanent structure and unmovable. Our Sandcastle package is limited to one location unless you would like to pay a generator fee for a different location.

Parking: If you choose to host your event at any public beach, please note that there is **no reserved parking**. Public beaches are busy on the weekends especially in high seasons. Please allocate enough time for parking. If you chose to host your event at a private beach front property, parking for you and your guests should be arranged through the management.

Bathrooms: Some of the locations available for our tented events have public restrooms located in the pool area. Other properties do not and when one of those are chosen, one of the rented rooms must be used as the restroom for the event or an upscale portable restroom trailer can be rented as an alternative. By choosing to have a tented event, if the bride and groom choose a property without a public restroom then they must provide a room that the guests and vendors can use for bathroom facilities. The cost for a bathroom trailer is not included in this proposal. For the guests staying on site, we suggest that they use their own rooms for bathrooms. Please see the site list for which properties that do provide restrooms. If you having a wedding on the public beach, public restrooms will be available.

Ceremony Retainer: Your retainer, **50% of your balance** guarantees that your Wedding date and time are reserved with Sand Petal Weddings.. As a protection to our company, your retainer is non-refundable, as we do not book more Weddings than we can perform on a specific day and time. The first payment is due at booking along with this signed contract and an additional payment of 20% is due 90 days before the event , with the Final Balance due 30 days before your wedding date. A 5 day grace period is allowed for these additional payments due, however, if the payment is not received within the grace period, then your wedding is considered cancelled with Sand Petal Weddings unless other payment arrangements are made & approved thru Sand Petal Weddings.

Reception Retainer: Your retainer, **30% of your balance** guarantees that your Wedding date and time are reserved with Sand Petal Weddings.. As a protection to our company, your retainer is non-refundable, as we do not book more Weddings than we can perform on a specific day and time. The first payment is due at booking along with this signed contract and an additional payment of 20% is due 90 days before the event , with the Final Balance due 30 days before your wedding date. A 5 day grace period is allowed for these additional payments due, however, if the payment is not received within the grace period, then your wedding is considered cancelled with Sand Petal Weddings unless other payment arrangements are made & approved thru Sand Petal Weddings.

However, Please note that the Chickee Hut Reception package requires final payment **60** days in advance.

Package Changes: Once a deposit is received, a package can only be changed if it is of equal or greater value. Ala cart items can be added at any time and an invoice will be given reflecting the additional requested items. In the instance where a package change of equal or greater value is made, the deposit already paid will be applied to the new package and a contract addendum will be written, the current contract will remain in full effect until we receive the newly signed addendum.

Postponement: Because unfortunate circumstances can occur, you may postpone your date for up to one year from your original wedding date. All pre-paid monies will be applied to your new date. This postponement must be made at least 150 days before your scheduled event. If you must postpone, you must choose your new date within 60 days from the time you contact

us with your request to postpone. Any Postponement or Change of Date will be charged a \$200 fee that must be paid before change is implemented. Due to unforeseen vendor price increases, a 15% fee of total wedding package cost may be charged and this fee must also be paid at the time of postponement unless other arrangements are made with SPW. If you find you need to cancel indefinitely, your deposit and all monies paid are non-refundable and non-transferable.

Cancellation: Due to unfortunate circumstances, a Bride and Groom may find that they need to cancel their wedding indefinitely. If a Bride and Groom do not choose to postpone their wedding date (as outlined in the postponement paragraph) and instead decide to cancel their wedding, then a cancellation letter must be signed by either bride or Groom to officially close your file. Once we received the signed cancellation letter, we will inform all of the booked vendors that the wedding has been cancelled and your file will be closed. All deposits and monies paid are non-refundable. No refunds will be issued.

Ceremony Rain Policy: : If rain or inclement weather should occur on your scheduled wedding date which prevents an outdoor ceremony it is the couples responsibility to provide a back-up location. Sand Petal Weddings will be happy to suggest some area options. If a backup location is chosen, Sand Petal Weddings must be given the new location the morning of the wedding day. If need be, Sand Petal Weddings, based on their availability, may be able to perform your ceremony earlier or later in the day or the following day. Sand Petal weddings cannot set up your décor if inclement weather is being predicted 4 hours before your ceremony. If ceremony set-up has already been completed and inclement weather or rain prevents an outdoor ceremony, Sand Petal Weddings will not set up again on any other day and cannot issue a credit or refund..

Reception Rain Policy: : If booking our Basic Tented event and inclement weather should occur, the ceremony can be held under the main tent. The Basic tented event includes walls which can be rolled down if it should rain which protect your guests and the tables and the wedding will continue without interruption. If booking our Sand Castle event, Chickee Hut or our Cake & Champagne reception and inclement weather should occur on your scheduled wedding date which prevents an outdoor wedding/reception, the event would need to be moved to an indoor back up location. Sand Petal Weddings will be happy to suggest some area options. The decision to move the event would be ultimately made by Bride & Groom after consulting with the lead coordinator the morning of event day. The cost for the back up room are the Bride & Grooms responsibility. Sand Petal Weddings cannot set up your décor if inclement weather is being predicted 4 hours before your ceremony. If Bride & Groom decide to move forward with an outdoor wedding regardless of weather and wedding set-up has already been completed and inclement weather or rain prevents an outdoor ceremony, Sand Petal Weddings will not set up again on any other day and cannot issue a credit or refund.

Permits & Fees: Sand Petal Weddings package options do not include any required beach permits that may be required for public beaches, parks, and use of other private venue locations. Public beach permits start at \$225 and vary based on the actual beach. Any applicable permit fees must be paid along with your retainer to assure the reservation of your location. ( Sunset ceremonies on the beach are very popular and book quickly. It is imperative your date is reserved in advance.) Sand Petal Weddings will handle the obtaining of any needed permits on your behalf when possible. Sand Petal Weddings ceremonies can be held at public beaches as well as private beaches. Tented events can only be done at private residences and private hotel/motel/resorts . A Tent permit fee may or may not be applicable based on beach location and any changing government permit laws. When choosing a Tented event we will give you a list of beachfront hotels to choose from to hold your event at. These hotels in turn require room rentals and/or site fee. Our Sandcastle package is limited to one location unless you would like to pay a generator fee for a different location.

Marriage License: Package prices do not include marriage license fees. Applicants must apply in person at the Clerk of Court and bring a Drivers License, Photo I.D. or Passport. If either applicant was previously married, the date and county the prior marriage ended by divorce, annulment, or death is required. If it has been less than six months, documentation may be required. The fee is \$97.50 . Florida residents have a 3-day waiting period; however, non-Florida residents have no waiting

period and will receive their marriage license the same day.

**Time Restraints:** It is imperative that the wedding party and guests be at the wedding location at least 30 minutes prior to when the ceremony is due to begin and the bride at least 15 minutes before ceremony. Due to time restraints we cannot guarantee all photos (when applicable) are taken if the Bridal party is late. Time allotted for sunset photos and dinner and other varying vendors such as Musician and Officiant, (when applicable) can be affected by a late arrival as well. No credit or cost adjustment will be issued if this circumstance occurs.

**Photos:** Permission is granted for Sand Petal Weddings to use on their website or in marketing materials, photos taken at event

**Officiant:** An Officiant is included in the SPW wedding packages unless this service has been removed by the bride. The Officiant that SPW provides will take care of filing the marriage certificate on behalf of the bride and groom. The Officiant provides several standard vow selection's. If any customization or additions are desired in regards to the vows, ring exchange or ceremony in general, the Officiant has an additional \$100 customization fee which will be collected by SPW

**Florals and Decor:** All silk florals, greenery, alter arrangements; aisle markers, arches, pillars, tiki torches, decor and the like are the exclusive property of Sand Petal Weddings LLC and are for display only and not intended for purchase.

**Delivery, Set-up & Take-down:** For your convenience, our package plans include the delivery, set-up and take-down of all decor supplied by Sand Petal Weddings.

**Ceremony/Reception Coordinator:** Your ceremony/reception package includes a ceremony coordinator. Your coordinator is available to answer your questions via email and phone. Your coordinator will line up the bridal party and assist in the processional & recessional. If adding a reception, the coordinator will create a time line for your reception events. If the bride has items that need to be set out, a family member will have to be designated to take care of those items. Please refer to the bridal questionnaire for details.

**Seating:** For packages that include chairs, please be sure to designate a family member or friend as an Usher to assist guests in finding their designated seating assignment. If you are having open/casual seating then please make sure that the front row seats are reserved for parents, grandparents, special guests...

**Performance:** The performance of this contract on behalf of Sand Petal Weddings, shall be contingent upon acts of God, flood, fire, warfare, government laws or regulations, electrical failure, strikes by suppliers, vendor equipment failure, and/or conditions beyond it's control.

**Food and Beverage:** Sand Petal Weddings in not liable for any services or food or beverages that a vendor supplies. A final guest count is due 30 days before the event. If at that time you have more guests than the contract states, you may add them when your final payment is due; if you have less guests, you may receive a credit on your final bill from Sand Petal Weddings. (an addendum to your contract must be signed to change guest count.)

**Wedding cake:** (when applicable) If your package includes a wedding cake, you must choose a cake design and flavor choice from our wedding cakes web page. If you should want a larger cake than needed or a specialty cake that goes outside of the choices provided that charge will be added to your final balance due. The cake provided includes butter cream frosting, to have a fondant frosted cake, would be an up charge.

**Bar Tab:** These packages do not include a bar tab but some do include (when applicable) self serve soda and bottled water. If you would like to provide your own alcohol to your reception event, you are allowed to do so, however, please note that Sand Petal Weddings will not play a part in that portion of your event and you must bring all your own supplies, including but not limited to, a table, cups, ice, cooler, etc. Please also note that glass is not allowed on the area beaches, so you must only provide cans or plastic cups or pre-mixed drinks in gallon jugs, for you and your guests. If you would like to add an actual Bar and Bartender, please contact us for pricing.

**Music:** Packages containing recorded music are limited to the selections we have available. You will find all of the options to



choose from in the bridal questionnaire that you will receive in the Welcome Packet/Welcome Email. \$50 fee for personalized music choices (upon availability).

**The Basic Tented Reception event lasts for 3 Hours.** The Basic Tented package is timed to end at SUNSET as lighting is not included. If you would like to add an additional hour of time for dancing, the fee for Globe Lighting, Staff, Dj, and Wedding Coordinators for the additional hour is \$595.00, making the Reception a total of 4 Hours. This one hour must also be added at least 30 days in advance of the event as the lighting must be ordered in advance.

**The Chickee Hut Reception event lasts for 3 Hours.** Lighting is available in the Hut, however events must end by 10:00 p.m. due to county sound ordinances.
