This fee also covers the cost of the Bridal Makeup Trial. **It is recommended to pay the \$150 deposit ASAP since it secures your wedding date.**

BOOKINGS: To secure a date and time, a signed bridal contract and non-refundable and non-transferable deposit of \$150.00 deposit are required for makeup service. Every effort will be made to secure your date and time, but bookings will operate on a first-paid basis. Contact me immediately if there are any significant changes in the wedding timetable to avoid overbooking, as several weddings may be taking place on the same day. **There must be a minimum of 4 people when booking makeup & hair services.** Payment for the Bridal Makeup & Hair Trial/Consultation will be paid on the day of the service and the wedding day services will be due on or before the day of the wedding. Accepted forms of payment include: cash, check, and Venmo/Apple Pay. Gratuity is not required, but always appreciated.

SCHEDULING: 90 days prior to the day off, I will send over a copy of the day of scheduling which will consist of the timing for all services which the bride will approve of. **IF YOU CANCEL IN THE 90 DAY PERIOD, YOU WILL BE CHARGED FOR THE ENTIRE WEDDING DAY TOTAL.**

CONSULTATIONS: Consultations are available for brides as well as their bridal party members, including but not limited to: bridesmaids, mother of the bride and groom, grandmothers, extended family members, guest speakers, etc. NOTE: Additional consultations must be scheduled on the same day as the bride's consultation in order to avoid an additional travel fee.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if the scheduled makeup application exceeds the allotted time due to client delays.

SATISFACTION GUARANTEED: Makeup will be completed to the client's satisfaction, and acceptance of the completed makeup application is acknowledgement by the client that the makeup is done to the client's satisfaction.

PARKING/TRAVEL FEES: Where parking, valet or toll fees may be incurred. This amount will be included in the final bill and will be due on the day of the event. Travel within 15 miles of Yardley, Pennsylvania, 19067 is completely free of charge. A mileage fee will be determined if location is outside of the 15 mile radius of Yardley, Pennsylvania. Travel fees apply for all pre-event makeup consultations as well as day-of appointments.

LIABILITY: All brushes, tools, and makeup & hair products are sanitized between every makeup/ hair application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application. Client(s) agree to release the makeup artist (Jess Mitchell) from liability for any skin complications due to allergic reactions.

PAYMENT: The final balance is due on or before the day of the event before the makeup artist departs — no exceptions. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this contract.

CANCELLATION POLICY: Cancellations must be made **90 days prior to the client's reserved wedding date** or the client will be responsible for paying the full amount of services agreed upon in this contract. If the trial is cancelled less than 1 week before the trial date, a \$200 dollar cancellation fee/rescheduling fee will be charged. If the makeup artist must cancel the event, due to illness or some unforeseen emergency, all payments will be refunded in full.
