## **Wedding Makeup Service Agreement**

This contract outlines an agreement and all contractual obligations made on \_\_\_\_\_[*date*], between Pamela Bob, here referred to as **WhoDoesYourMakeup** and \_\_\_\_\_[*name*], of \_\_\_\_\_[*address*], \_\_\_\_\_[*city*], \_\_\_\_\_[*state*], \_\_\_\_\_[*zip*] here referred to as Bride.

- ■Bride and/or wedding party agrees to a signed contract for **WhoDoesYourMakeup** and any additional artists as per agreement to provide makeup and/or hair services on the date and time agreed.
- ■**WhoDoesYourMakeup** agrees to perform these services for bride and wedding party under the terms and conditions set forth in this contract.
- ■Accuracy of this form is extremely important in providing effective and timely services by the Artist in consideration of the mutual promises set forth in this contract; it is agreed by and between Bride and **WhoDoesYourMakeup**.

### **Relationship Of Parties**

**WhoDoesYourMakeup** is not to be considered an agent or employee of bride for any purpose. The parties intend that an independent contractor relationship will be created by this contract. Bride is interested only in the results to be achieved; the conduct and control of the work will lie solely with **WhoDoesYourMakeup**.

## **WhoDoesYourMakeup obligations**

- Artist shall perform the Services promptly on the date and time agreed.
- If Artist cannot perform the agreed upon services due to unforeseen circumstances or any other cause beyond her control, any and all payments shall be returned to the client with the understanding that there will be no further liability with respect to the agreement.
- **WhoDoesYourMakeup** shall use her own products in the provision of the Services
- **WhoDoesYourMakeup** will arrange means of transport and have their own mobile phone but may claim legitimate expenses subject to prior agreement.
- Makeup Artist will use good quality professional materials.

## **Bride Obligations**

- Bride agrees to pay Fee in accordance with Payment provision.
- - Bride is responsible for **WhoDoesYourMakeup**'s fees, assistant fees, parking and travel fees.
- - Bride agrees to immediately inform **WhoDoesYourMakeup** and its assistants regarding any sensitivities or allergies they may have to any types of makeup, products, or treatments.
- - Bride agrees to inform bridal party to inform **WhoDoesYourMakeup** of any sensitivities or allergies they may have to any types of makeup, products, or treatments.
- - Bride and bridal party will *provide pictures of their hair and/or makeup ideas/ inspirations in advance of the wedding day, with the understanding that the Artist will do their best to as closely replicate that look as time limitations will allow.*
- - It is not required, but strongly suggested that the members of the bridal party (and/or Bride) have their own lip color/product of choice to be able to apply and re-apply for the rest of the day/evening. WhoDoesYourMakeup will provide the initial application from her own kit, if preferred, and will do everything to ensure the longest lasting product.
- - Each person receiving Hair and/or Makeup services has a scheduled allotted time. WhoDoesYourMakeup is not responsible for any late comers, and will need to abide by the scheduled times in order to ensure the Bride is ready by the required time.
- - If a member of the bridal party wants significant changes to their hair and/or makeup after their scheduled time, an additional fee of \$50 will be applied per service.

- ▪   Bride may add additional people for Hair/Makeup services any time if the schedule permits is, with the understanding that it will affect scheduling changes the day of the event.
- ▪   Bride may cancel Hair/Makeup services up until 30 days before the event. If cancelling within 30 days of the event, 50% PAYMENT is expected for the cancelled services. If cancelling within 2 weeks before the event, FULL PAYMENT is expected for those cancelled services. There are no exceptions.

## **TRAVEL**

If **WhoDoesYourMakeup** is required to travel out of state or more than 1 hour out of New York City or due to an early call time before 7am, extra charges will incur.

If travel time is more than 2 hours with a start time before 7:30am, the bridal party is responsible for lodging all artists the night before the event.

Bridal party will be responsible for lodging, travel, (including parking fees, toll and gas) and per diem allowance for meals.

## **CANCELLATION POLICY**

You may cancel this contract 30 days prior to the wedding date. If less than 30 days you will be responsible for 50% of the total balance due. If you cancel within 1 week of the wedding date, you will be responsible for 100% of the total balance due. This is non-negotiable.

Payment in full is due any time before the event up to the day of the event via cash, Venmo, PayPal, Zelle or check. If paying by credit card, a 3.5% fee will be added to the total amount.

## **LIABILITY**

Bride agrees not to hold **WhoDoesYourMakeup**, its agents, assistants, and staff responsible for any allergic reactions developed as a result of the make-up application that may occur to Bride or bridal party.

## **ADVERSITING**

Bride agrees to allow **WhoDoesYourMakeup** to take before and after pictures and to acquire professional photos from the Wedding Photographer to use for promotional use for advertising purposes on its website and other promotion materials.

## **ENTIRE AGREEMENT**

This agreement represents all the terms and conditions agreed upon by the parties. No other understanding or representations, oral or otherwise, regarding the agreement shall bind any of the parties.

## **DEPOSIT**

Prior to the wedding, **WhoDoesYourMakeup** will perform a Makeup/Hair Trial, to determine the final look, per the requirements of the Client.

Upon receiving a 50% as a deposit, this will be considered a booking. Bride will be paying ***Pamela Bob*** of **WhoDoesYourMakeup** a non refundable amount after 30 days before the event.

The remaining balance is due upon completion of services by and up to the day of the wedding. All necessary travel fees are included in quoted prices.

### **HAIR & EYELASHES**

I do simple styling as well as more intricate up-dos. I do not bring extensions, or sew in extensions. Clip ons or hair bands, provided by the client, are accepted.

Blow outs are an additional fee as they require more time. I do not cut hair.

Please consult with Pamela first before hair requests.

### **ADDITIONAL ARTISTST**

**For larger parties, more than 1 artist is needed. For every additional artist, there is a \$50 service fee.**

### **HOW LONG DO I STAY?**

There is an additional fee of **\$50/hour** if I am needed to stay after the initial scheduled makeup service has been completed for any touch-ups or changes before and/or after the wedding ceremony and/or reception.

### **PHOTO SHOTS - ENGAGEMENTS, ANNOUNCEMENTS, ETC.**

Bride: **\$300** for Makeup  
**\$400** for Makeup AND Hair

Groom: **\$75** for hair and makeup

\*\*\*Male makeup, more known as “grooming”, is strongly suggested. It focuses on

skin conditioning, mattifying the skin to prevent oil and shine, and evening out any discoloration without looking like you are wearing any makeup at all!

Additional fee of **\$50/hour** if I am asked to stay for touch ups/changes for the duration of the shoot.
