BOOKING PROCESS/DEPOSIT

A \$100 deposit is due at the time of booking. Your deposit covers all general travel expenses for all artists/stylists/assistants for your event. Due to all of the equipment necessary for on-location services, the artist will park valet/on-site when available. Your deposit will secure your date/time for you & your bridal party. Please note that your deposit is not put towards your service cost(s).

PAYMENT

The remaining balance is due 30 days prior to your wedding date. This payment will be requested via Venmo or PayPal.

If you DO NOT have a PayPal or Venmo account, please take a moment of your time to download the free application. Once downloaded, please create an account to process payments. It is free of charge & are no processing fees.

services) are made, if any cancelations occur, your payments are nonrefundable & nontransferable.
