\$550 Traditional Ceremony: This is a more traditional ceremony that's kept short and sweet. It still brings a uniqueness to your wedding without being boring and cookie cutter. It saves both time and money by eliminating ceremony-editing and writing time as well as in-person meetings that we would normally set up with the custom ceremony (everything is done via phone and email). With this package you'll choose from a few pre written ceremonies that are designed to be performed as written and priced accordingly. Many of the core components from the custom ceremony will remain the same for this package aside from the in person meetings, custom written ceremony, and edits/re-writes of prewritten ceremony script. You'll still receive an introductory phone conversation as well as unlimited phone and email support. Then, prior to the wedding day, I will email you a detailed, personalized ceremony script and we'll also schedule a 15-20 minute phone call a few weeks before the wedding to go over the script and answer any questions you might have.

\$700 Custom Ceremony: This includes a complimentary introductory meeting or skype/facetime session with you and your spouse which allows me to get to know the two of you (and vice versa) and understand your style and story to help me write a personalized ceremony. If the shoe fits as they say we'll arrange a second meeting closer to your wedding date to actually write the ceremony or at least brainstorm ideas and let me know what you want in it - this allows you the ability to help co-create the ceremony and add any wording to it that you may desire. The second meeting is optional and can be done over the phone but some couples do prefer the face to face interaction. Additionally, this price includes unlimited phone and email support and mileage to and from. We can also include readings from a friend or relative, or if you'd like to incorporate something different like lighting a unity candle, we can do that. Core Components:

- Getting to know you meeting (initial consultation) and one ceremony-writing meeting
- Telephone and email consultations
- Individually-written ceremony
- Written script of ceremony
- Arrival of officiant 45 minutes prior to ceremony for pre-ceremony coordination
- Performing of ceremony
- Signing of marriage license

I do ask for a \$150 deposit to secure the date and my services, which comes out of your total. Then the remaining balance will be due no later than 30 days before the date, that way we have nothing to worry about come wedding day other than making sure you have a seamless ceremony.

If you would like to proceed after reviewing the information above here's how it would work: (Note some of these steps might not apply for the second, more traditional package I have listed above)

- 1. We'll set up the introductory meeting
- 2. After we meet and get to know each other you and your spouse can go back home to think things over
- 3. If you decide to book, send me an email confirming, I'll put a temporary hold on your date and send you a wedding contract to sign and be returned with the \$150 deposit
- 4. We'll arrange the second meeting as your wedding date approaches
- 5. All final edits will be done via email or over the phone
