Upon receipt of Page 2 of this contract and a \$190 retainer, we will be in touch to schedule your initial consultation, which will include the preparation of the quote and secure dates for your trial.

Important information

We charge for incurred parking expenses for our Pro-To *Stay* Program. Average parking expense is \$50 for 6 hours.

We do not accept a bride without a prior consultation. Although not ideal, this consultation can occur while your wedding party is getting their pre-wedding blowouts. If you forfeit your trial the cost on your wedding day is double the quoted price for Bridal Makeup & Bridal Hair.

All pricing excludes gratuity. A 20% gratuity will be added to your final invoiced amount for day-of services.

There is an after hours convenience fee of \$100 for services starting before 8:00am or finishing after 5:00pm.

To ensure our availability, we encourage you to book your services as early as possible. A date is secured only when a signed contract AND a \$190 deposit is in place.

All on-site wedding services incur a minimum charge of \$250. This does not include Trial or Consultation services.

All Pricing includes up to 4 hours of services and up to 2 stylists. If more stylists are needed, there is an additional stylist fee of \$75/stylist.

Contract Details

This contract requires a \$190 deposit and secured with credit card information to reserve your date and schedule appointments. The \$190 deposit is used to pay for your trial. If your trial only includes hair OR makeup, the remaining deposit balance will be applied to your day-of-wedding services. Your pre-wedding blowouts are paid for at the time of service. Your wedding day-of-services payment is due 2 days prior to the day of the wedding (via cash, credit card, or payable through an on-line invoice. Should there be a need to adjust or cancel any appointments, we ask that all changes and/or cancellations be made at least 14 days prior to the wedding date. After the event if there are any unpaid balances, they will be charged to the credit card on file.

Cancellation Policy:

14 or more days prior to the event: deposit forfeited but no additional charges

Less than 14 days prior to the event: full amount of services booked will be charged.

No Show/Missed Appointments: full amount of service will be charged

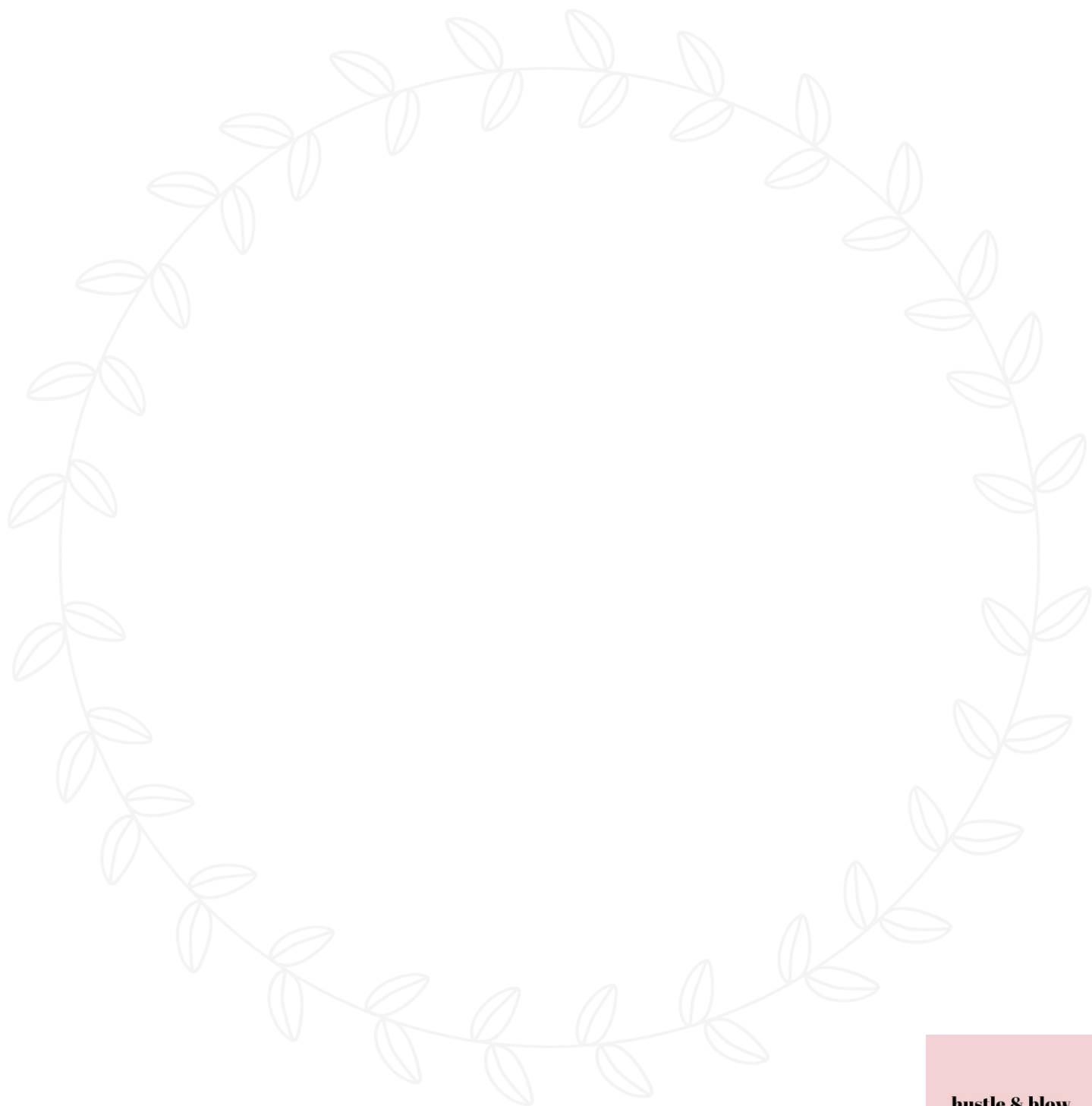
