\$1400 Ceremony with up to 100 guests (includes white chairs, arch, sound equipment bathrooms, and parking) 4-hour total; 1-hour set-up, 1 hour with guests, 2 hours for pictures and clean-up. Additional \$500 damage deposit, 100% refundable after the event.

\$2300 Ceremony & Reception with up to 50 guests (includes white chairs, arch, and sound equipment for the ceremony; tables, chairs, and linens for reception; restrooms, and parking. Bring your own caterer, beverages, and DJ! Additional \$1200 damage security deposit, 100% refundable after the event.
