



## MAKEUP SERVICE CONTRACT

In consideration of the mutual covenants herein contained and, intending to be legally bound hereby, the Client and the Makeup Artist agree as follows:

1) Makeup/Hair Artist's obligation to give services hereunder is subject to the unavailability of the Artist as a result of sickness, accidents, acts of God and other reasons beyond the Artist's control. If this occurs, AMC will notify client and provide a suitable replacement artist.

6) **PAYMENT** In full consideration for all services rendered by the Artist at the location, the Client agrees to make the following payment in cash to the Artist

a) **DEPOSIT** Client will pay **\$115** (for makeup) & **\$115** (for hair) to Artist as a cash/Zelle to book the date

b) **Cash ONLY payment day of:** At the event on the set date of services needed, the Client will pay the Artist(s) the remaining balance of the payment

All rates are non-negotiable & must be paid in cash



### **Hair Rates**

Bride day of: \$125

Bridal trial: \$105

Bridal styling/updo: Starting at \$95 up to \$125

Blowout: \$65

Flower girls: \$60

Clip-in hair extensions (not provided): Starting at \$20 and up

### ***Minimum per artist (hair):***

\$500 Minimum for 1 artist for onsite services

\$1500 Minimum for 2 artists for onsite services

All rates are non-negotiable & must be paid in cash

**7) CANCELLATION.** In the event Client cancels the Project prior to 30 days of scheduled date, **Client must pay full payment balanced owed to AMC.** Upon payment of the cancellation fee, Client will have no further liability to AMC hereunder. Any changes made to contract must be within 90 days of event. AMC may cancel this contract at any time and for any reason, and any form of notification to the Client of the cancellation (whether by text, email, voice mail, or otherwise) is valid. In the event of any such cancellation by AMC, AMC will refund the deposit amount to Client, less any incidental expenses reasonably incurred by AMC. If the contract is cancelled on the day of the services being performed by AMC, then AMC shall be entitled to a pro-rata rate for any such services actually performed up to the point of cancellation. Such cancellation may be made for any reason, and AMC shall not be liable to Client for any losses, expenses, or alleged damages Client sustains due to said cancellation for any reason.

**8) MISCELLANEOUS.** The Wedding Agreement and the attached rider(s), if any, set forth the entire agreement between the parties, and may not be amended except in writing signed by both parties. This Project Agreement will be governed by and construed in accordance with the laws of the State of Illinois, without regard to the principles of conflicts of law. In any action or proceeding involving a dispute between the Client and the Artist arising out of this Project Agreement, the prevailing party will be entitled to receive from the losing party reasonable attorney's fees. Makeup/Hair Artist and Bride have each caused this Service Contract to be signed by it duly authorized representative.

**9) LIABILITY WAIVER.** Artist assumes no liability for any damages or claimed damages arising out of this contract or the provision of services under this contract, and Client hereby waives any and all claims for damages against Artist or any of Artist's employees or subcontractors, which arise out of this contract or the services provided under this contract. Client hereby agrees to defend and indemnify Artist for any and all claims, lawsuits, and demands which may arise out of this contract or the provision of services under the contract.
