After over a decade as a wedding photographer, I've learned many things about the pricing and packaging aspect of weddings and the most important thing, is there is no one set price for wedding vendor services. That is why I use a broad pricing structure that offers a *suggested* price. However, so many different factors detail into the cost; guest count, length of the day, second photographer, number of locations, videography, printing, albums, editing time, etc., so choosing a package closest to your desire and budget is the best way to start, then we can begin customizing from there.

The following document is a starting point for pricing and packages, each package can be custom tailored to your event specifically. Nothing is more of a compliment when my photography work resonates with other people enough for an inquiry, and for that I'm always willing to negotiate with pricing especially with fun and loving couples. My goal is to make you feel completely comfortable with the services offered so that I can make you feel completely comfortable in front of the camera to make you look your absolute best on your big day!

** All wedding packages include a no commitment consultation to discuss artistic direction of wedding and engagement photography.

ADD ONS

**Wedding videography may be added to any package or booked as an individual package upon request, starting at \$2,500. Inquire for further details.

**I offer a slideshow of selected photos from the wedding day to play during reception on video monitor I provide. This is a wonderful feature for your guests to see the entire day in about 20 images during the reception. Free with packages 2 and 3.

**Rehearsal / Dinner Rehearsal Coverage - If there is a rehearsal within a few days of the wedding event, I am able to provide additional coverage to that. \$100 hr. Which can be added on to the final price and added on at any time.

** Additional Hour - After agreed upon length of event. Due to unforeseen circumstances if the schedule get's pushed back, I am able to provide additional hours of coverage.



TERMS AND CONDITIONS

Securing services - A first installment payment equal to 50% of the package price is required in order to reserve my services for the wedding date. A second and or final installment equal to 50% of the package price will be due by the wedding date. Joseph Henry will not begin services until this payment is received. If the client cancels the production at least one month prior to the wedding date 25% of the final deposit/payment is non refundable.

The client is solely responsible for securing permission from the site owner/operator for use of the production site as well as authority for my photography team and I to set up all necessary production equipment. It is understood that the quality of the production is dependent upon adequate lighting, camera/microphone positions and other conditions not under the control of Joseph Henry Photography. I will not be responsible for any outside fees that other vendors may charge examples include, but not limited to: site fees, use of vendor/venue equipment, etc...



Hours of filming/shooting are to be used consecutively, if client wishes to have a break during the duration of scheduled hours the client will be charged a rate of \$50 per hour, for each hour of the break.

Turnaround - I guarantee the turnaround time given for the delivery of all photography will be under 8 weeks for any wedding. The turnaround time for videography services will be under 8 weeks. For any client utilizing both photography and videography services for the same event will have a turnaround time of 10 weeks. In most cases, the delivery of products will be under the given window of allotted time.

QUALITY STANDARD

Photography and Final Prints/Images: All album print products will be corrected for exposure and color. My quality standard target is measured by five guidelines: 1) highlight details are visible, 2) shadow details are visible, 3) whites are clean with no overall color cast, 4) the image has no overall color bias (this does not apply to color balance for lighting conditions), 5) skin tones are believable. Because lighting conditions and movement provide constant challenges, I cannot guarantee the quality of any image. Any requested retouching after delivery may incur an additional charge. Any creative touches/assembly outside of standard quality pictures is at the discretion of Joseph Henry Photography as verified by client when viewing sample work.




While every reasonable effort will be made to produce and deliver outstanding photographs and/or videos of the wedding event, Joseph Henry Photography's entire liability to Client for any claim, loss, or injury arising from the photographer(s) and/or videographer(s) performance is limited to a refund to Client of fees paid. Client understands that they are responsible for protecting personal items during the event and/or photo/video sessions. Because this is an uncontrolled event, I cannot guarantee delivery of any specifically requested image(s) or shot(s). The agreement of the service to perform is subject to proven detention by sudden illness, accidents, acts of God, or any other legitimate condition beyond the control of Joseph Henry Photography. In the unlikely event of personal illness or other circumstances beyond the control of the

photographer(s) or videographer(s), a substitute photographer or videographer of equal qualifications may be dispatched by Joseph Henry Photography to fulfill the obligations of photography and/or videography herein contracted.

I will establish an arrival time for the wedding date with the client prior to that date and remain on duty for the number of hours included in the package. Coverage hours included in the package are for the wedding date only and must be consecutive. This block of time includes transportation between venues and meal breaks.

Joseph Henry Photography reserves the right to discontinue recording and photographing in any situation (ex: rain, extreme temperatures, humidity, hazardous locations) that could put the safety of the videographer/photographer and/or equipment at risk.



Cameras according to package chosen will be used to record/shoot the ceremony. The aesthetic quality of this video/pictures mix may vary depending upon the logistics and lighting of the wedding/reception site and the permitted camera placement.

Any expenses incurred by Joseph Henry Photography not pertaining directly to the production of the video (ex: out-of-town accommodations, tux rental, parking, shipping, etc.) will be added to the client's balance.

The completed service will be considered a finished product, and any additional requested revisions will be added to the client's balance for an additional fee.

The original footage/images remain the property of Joseph Henry Photography. The client gives Joseph Henry Photography permission to use footage from the original tapes to market Joseph Henry Photography's wedding photography services. The client is responsible for all copyrighted music used in the wedding video. Joseph Henry Photography's purchases rights to all music used in (short) highlight videos. Music used in documentary (long format) package rights are not purchased by Joseph Henry Photography, couple agrees not to post publicly if choosing the documentary (long format) packages.

Any special requests overriding the terms and conditions of this contract must be specified in the Wedding Production Worksheet during the final consultation prior to the wedding date.

Client agrees to provide vendor meals to videographer(s) and photographer(s) during guests' meal time.

Rehearsal Coverage: If selected as an add-on, I will attend the wedding rehearsal to record/shoot footage and examine the logistics of the ceremony as well as the site.

Rehearsal Dinner Coverage: If selected as an add-on, I will attend the rehearsal dinner for no longer than two hours to record/shoot footage. Any time exceeding two hours will be added to the client's balance for an additional fee. I will notify the client when the two-hour time limit is nearly reached.

Additional Hour of Coverage: Full-wedding coverage length is agreed upon before the wedding date. If selected as an add-on, I will include the additional coverage time when establishing arrival and departure times with the client for the wedding date. Additional hours must be consecutive with the block of hours already included with the package.

Raw Footage: If selected as an add-on, the client will receive one flash drive dub of all raw footage videotaped. I will not be responsible for any material in the raw footage that may be offensive or disturbing to the client.

Stored and Hosted Media: I will store and host online all images and complete highlight videos for 6 months after the event. All proofs and raw footage will be stored for 6 months after the event.
