- I. *All edited lengths are approximate, will vary slightly per project, and are open to the vendor's discretion.
- 2. For events located >60 miles outside the Salisbury, MD area, travel expenses will apply. Contact the vendor for a quote.
- 3. Payment can be submitted via mailed check, Venmo (friends & family), GooglePay (friends & family), Paypal (friends & family), or Zelle, but clients are welcome to ask if other apps/payment apps can be accepted.
- 4. The vendor typically brings an assistant with her to the event. Please provide 2 hot meals for the video team!
- 5. All music used in the final edited film(s) needs to licensed in order to be used responsibly/legally. Gretta Greenwald LLC is responsible for purchasing music licenses and all music choices are left to vendor discretion, however clients are encouraged to share their favorite musicians/genres with the vendor so that all final edited music fits the couple and is something they'll love.
- 6. The vendor will typically deliver the edited films 8-12 weeks after the event but cannot be held responsible for later delivery times.
- 7. Upon booking this vendor, the client acknowledges and agrees to the vendor's full sharing and advertising rights of the footage and edited films shot during and created from the event.
- 8. In the event of a reschedule required due to extenuating circumstances:
 - If the client books an available reschedule date within the same year as their original ate: the vendor will charge no additional fees, vendor holds onto the 50% booking deposit, the reminaing 50% due upon delivery of the edited film(s).
 - If the client books an available reschedule date in a year outside their original date's year: the vendor will charge the difference in their package price from the current year to the next year (usually about \$200-\$300), vendor holds onto the 50% booking deposit, the reminaing 50% due upon delivery of the edited film(s).
 - If no reschedule dates are mutually available, the vendor will return half of the booking deposit (25% of total cost).
 - If the booking needs to be canceled due to the vendor's personal needs: the full deposit will be returned and the client
 will owe nothing.
