




This is who will be running around with a camera your entire wedding day, capturing every moment for you to remember.

MY PROCESS



01 | CONNECT & BOOK

If it seems like we'll be a good fit, let's sign a contract and get your date in the books! I will collect your deposit, then we get to work.

02 | TIMELINE & PLANNING


I want to help your wedding day go as smoothly as possible. That's why we will have a consultation 4-6 weeks before the big day to review your timeline and I'll offer any suggestions if needed. This is where we'll also discuss any thoughts or ideas you two have about your film!

03 | THE WEDDING

The day is finally here! I'll arrive at the agreed-upon time, say "hi", then immediately get to work capturing every moment.

04 | DELIVERY

No later than 6 weeks after your wedding day, you will have a link to watch your film waiting in your inbox! I will then send you a link to download your film. If a video book is a part of your package, that will be shipped to you shortly after.

FAQ

WHAT THE HECK IS A VIDEO BOOK?

It looks like a photo album, but when you open it up, you see a screen and your wedding film begins playing. So long, USB drives!

CAN YOU USE THIS ED SHEERAN SONG I LIKE?

Unless you have thousands of dollars to pay the licensing fee, I cannot. However, I have access to a vast music library, so I guarantee I can find any music that fits your taste.

CAN I ADD ON TO MY PACKAGE?

Yes! Items listed in the Cinematic and Timeless packages are avaialable as a-lacarte items.

CAN I SPLIT UP MY PAYMENT?

Yes! As long as the balance is paid in full by the date of your wedding, we can work out a payment plan.

WHAT IS RAW FOOTAGE? HOW WILL I GET IT?

It is the clips I shoot straight out of my camera, unedited. If included in your package, any raw footage you want will be sent to you via Dropbox after your film is completed.

DO YOU CHARGE TRAVEL FEES?

For the Black Hills area and weddings within 3 hours driving time from Rapid City, there are no travel fees! All other weddings will be subject to travel costs/ reimbursements based on their distance from Rapid City.

DO YOU SHARE YOUR COUPLES' FILMS ON SOCIAL MEDIA?

Absolutely, but only after you watch it first and tell me you love it.

WHAT ABOUT ELOPEMENTS AND MICRO-WEEDINGS?

Sign me up! If this is the direction you're going, let's chat and go over the details. I'll create a customized quote for you.

01 | EMAIL ME

02 | WE'LL TALK

Any questions you have, I want to answer. I want to make sure that we will be a good fit working together.

03 | CHOOSE A PACKAGE

04 | SIGN & PAY

I'll send you a contract and invoice via Honeybook.

The deposit is due 3 weeks after I send you the contract.

05 | IT'S OFFICIAL!


Your search for a wedding videographer is over.
