# WEDDING CONTRACT

- The hair and/or makeup artist who performs(ed) your trial will be the same artist on your wedding day barring any emergency or situation beyond human control. Shear Radiance Hair & Makeup Studio (SRH&MUS) would attempt to send a suitable replacement stylist, and if such stylist could not be found, a full refund of your deposit will be given.
- Shear Radiance Hair & Makeup Studio will supply all makeup, styling products, and tools to guarantee non-contamination. All tools and makeup products provided by SRH&MUS are kept sanitary and are cleaned between every service in compliance with Massachusetts state law. We can use your product if requested, however, SRH&MUS cannot be held responsible for infection or injury it may cause.
- It is the full responsibility of any person receiving styling services to report any health condition that may cause harm to themselves or others relative to respective service. This includes allergies, cold sores, herpes outbreaks, fungal infections, conjunctivitis, and any other contagious skin or overall health conditions. Product testing prior to the service is always available.

I grant permission to Shear Radiance Hair & Makeup Studio to provide services such as the application of makeup, false lashes, hair and skincare products for the event requested. My wedding party and I agree to release the makeup artist(s), independent representative(s), its owners, and all employees of SRH&MUS from liability for any unforeseen skin complications that may arise from said product usage.

- Travel & Accommodations: SRH&MUS is happy to accommodate you at your location! We will bring everything we need, so that you may enjoy your privacy and celebrate without the stress of commuting to us. All parking, tolls, and overnight accommodations are to be paid by the client. Bride/client to provide room number or bridal suite name the night before the wedding. Please see the shareable menu of this contract for pricing.
- The Day Of Client Provisions: Please inform SRH&MUS of any pet or smoke situations of any kind in any of the locations where styling services are to be provided.
- Client to provide ample work-space and surfaces, in the best possible lighting. SRH&MUS suggests covering tables and the backs of chairs that hair styling will take place in order to avoid hair spray settling on furniture.
- Photo Release

I grant permission for the use of any and all photographs to be used for any and all marketing purposes including, but not limited to marketing materials, our website, trade shows, events, studio display, social media, etc. to SRH&MUS. **Shear Radiance Hair & Makeup Studio will consult with client photographer prior to using professional images.**

- Final Numbers: Should the number of guaranteed services drop within 30 (thirty) days prior to the event, the bride/client will assume financial responsibility for the number of makeup/hair applications/services on this contract.
- Wait Time: Should the artists/stylists be left waiting for more than 30 (thirty) minutes for the bridal party, or due to major delays on the part of the client, there will be an hourly rate of \$35.00 per every half hour. SRH&MUS wants to ensure you and your party have adequate time to get ready in a safe, fun and stress-free environment.

- Schedule: SRH&MUS does not provide a to-the-minute timeline, however, please be informed we allot 40-45 minutes per person for makeup applications, and 30-65 minutes for hair styling.
- Please note gratuities are not included and are greatly appreciated.
- It is the sole responsibility of the bride/client that your party is aware of payments and start and end times, so there is no confusion or delay in getting everyone prepared for the ceremony.

- Second location set up (hotel to venue)
