- Locations over 25 miles from the Artist's address will be subject to a travel fee of \$0.68/mile, round-trip.
- Other travel expenses, such as tolls and parking garage/valet fees, will be added to the client's invoice on the day of the event.
- Early Start Fee (\$150/hour before 8am)
- A Holiday Service fee of 25% will be added to all services booked on major holiday weekends (i.e. New Year's Eve, New Year's Day, Valentine's Day, Easter, Memorial Day, Fourth of July, Labor Day, Halloween, Thanksgiving, Christmas, etc.).
- Additional Fee of \$100 will be added if group number and timing requires additional artists. Per artist.
- Touch Up Services are available in addition to wedding day services. For any situation in which the client requests extra services for any determined amount of time after initial services are completed, there will be an extra charge of \$150 per hour.
- A minimum total of \$700 for services is required to book
- A signed contract and 30% non-refundable deposit is required to book. Deposit amount will be applied towards the final bill
- Final payment for service is due on or before the event day. Accepted forms of payment include cash, check, or ZELLE.
- In the event that final payment is not made on the day of services, an additional fee of \$200 per day will be added to remaining balance.



CONTRACT TERMS

Agreement by and between Makeup By Alby Artist _____, and Client _____, as follows:

Artist shall provide the services set forth on the attached Services Agreement, including any amendments, which is specifically incorporated into this contract. Client agrees to make the following payments and be bound by the following terms and Conditions.

1. Client agrees to the fees as detailed on page two of this document for the total sum of \$ _____.
2. 30% of the total sum, \$ _____ will constitute the non-refundable deposit and confirms reservation of the requested date. Deposit payment shall be payable upon execution of this Agreement and will be applied to the total sum of services listed in this paragraph.
3. The balance of the total sum shall be due on or before the event date, in the form of CASH, CHECK, VENMO, or ZELLE.
4. If cancellation occurs, written notice is required 90 days prior to the event date. Client shall remain responsible for payment of the full contract price if cancellation occurs without notice and Artist shall be entitled to recover all costs resulting from any breach of this contract.
5. The Artist shall not be liable for breach or failure to perform its obligation, if an illness, accident, inclement weather, governmental action or other events reasonably deemed beyond control of Artist, cause such failure or breach.
6. If Artist is unable to perform its services for any reason outlined in the previous sentence, Artist shall have the option to replace with another qualified make-up Artist (the "Replacement Artist") recommended by Artist. If a Replacement Artist cannot be furnished, Client will receive a refund of all monies paid minus any Trial Makeup or other services that were rendered.
7. If the Event is postponed for any reason whatsoever, including, but not limited to, pandemic or epidemic, and the Event is rescheduled by Client, Artist will use its best efforts to provide the services covered by this agreement. In the event Artist is unable to provide such services due a scheduling conflict, Artist shall have the right to replace with a Replacement Artist, recommended by Artist. If a Replacement Artist cannot be furnished by Artist or if the Replacement Artist is not acceptable to the Client, the Client will receive a refund of all monies paid minus any Trial Makeup or other services that were rendered.
8. The Artist makes no warranties and the Artist shall not be liable for any direct and consequential damages arising out of the performance of service under this agreement. Any bridal party members, other than the Bride, may choose to opt out of makeup service or be added to this Contract with written notice to Artist, no later than 7 days prior to the Event.
9. Those persons who are included in this contract are guaranteed services and if time allows additional clients can be added, on the event date for additional fees. Additional services on the event date are to be paid in the form of cash. Any bridal party members may choose to opt out of makeup service or be added to the contract with written notice no later than 7 days prior to the event.
