POLICIES

Deposit:

A deposit of \$190 (\$240 holiday) is required to reserve wedding date. The deposit is applied towards your final balance, which is due 30 days before the day of your event.

Changes:

Any changes must be made up to 30 days before the date of your event. Due to time constraints, if you add a person on the day of the wedding, they will not be guaranteed service. You may request to add services within 30 days of the wedding date, however, it is not guaranteed. If additions are accepted, the start and finish time will change.

Additional Fees:

For off-site locations, an additional fee of \$1.50 per mile will be applied to the distance travelled from 56 Elizabeth Street Forty-Fort, Pennsylvania, unless otherwise agreed upon.

Cancellation:

Any cancellations made after 30 days prior to the event are non-refundable. Cancellations made before 30 days prior to the event will be accepted, however the deposit will be non-refundable. Any other payments maid towards the final balance will be refunded up to 30 days prior to the event.

Payment:

For trial sessions, cash, check, or credit card will be accepted. For day of wedding services, we will only accept cash or check as a method of payment. We apologize for any inconvenience this may cause.

Allergies & Sensitivities:

Artist cannot guarantee or be held accountable for any allergic reactions or complications from the products of the application. Individuals with sensitivities may bring in their own products to be used during their makeup service.

Miscellaneous Policies:

The artist has the right to remove any individual who causes a disruption to the bride during time of services. This is to ensure that the bride receives a quality, stress-free service experience.
