The non-refundable deposit of 20% is payable at time of signature to reserve your wedding date. The complete balance (final payment and any additional costs listed and/or selected above) is due within one week of your wedding date.

Rescheduled weddings will only be accommodated if the new date does not conflict with UpAngle, LLC scheduling. UpAngle, LLC will be the exclusive professional videographer. Friends and family are permitted to operate video cameras on the condition that they do not interfere with or get in the way of the professional coverage. It is the client's responsibility to secure access to areas for videography. UpAngle, LLC. will not be responsible for coverage lost due to access restrictions.

Creative aspects such as shooting and editing style are at the discretion of UpAngle, LLC.

Music choices can be selected by the client prior to the wedding day or UpAngle will make a decision based on video content and wedding style. Music must be chosen from reputable licensing websites where UpAngle is able to get the music legally to use to create the wedding film. Any music requests made after wedding day completion may be subject to additional fees to cover licensing of new songs.

Requested video edits or changes post product completion will be accommodated, however, additional fees will be incurred to cover the additional editing time.

UpAngle, LLC. will not be held liable for any production problems beyond our control, e.g. bad weather, accidents, poor acoustics/lighting, interference from guests, photography flashing, etc.

UpAngle, LLC. reserves the right to terminate this contract at any time for any reasonable cause, e.g. accident or ill health, or other unforeseen circumstance. In this event ALL monies paid will be refunded in FULL.
