Start time cannot be changed without notifying us in advance and getting approval from us via email.

I have read the complete description of what is included in the booking and all questions have been answered to my satisfaction. A booking fee of at least 50% must be made to reserve my wedding date with the balance due no later than the day of the wedding prior to the ceremony.

Upon signature and receipt of booking fee, We Do...I Do's will reserve the time and date agreed upon to plan our wedding ceremony.

We do accept personal checks if booking at least 45 days prior to your wedding. Please make check payable to: Marty Holmes

Marriage License: I also understand that it is my responsibility to acquire a valid marriage license in the state where the wedding ceremony will take place and that the marriage license must be on the premises when the ceremony is performed. I understand that failure to have these legal documents means that We Do...I Do's can not perform a legal wedding ceremony. The officiant can perform a symbolic ceremony, which will have no legal merit, and perform another ceremony in private for the couple once the legal documents are presented, for an additional fee. I will consult with our local court / city clerk to find the exact requirements for my area.

Refund policy: I acknowledge that 50% of the total is a booking fee to reserve my date and is non-refundable once date is booked. If I must change the date or time of my wedding it will be rescheduled on the new date or time if it is available. If my new date or time is not available, the change will be considered a cancellation and I will forfeit

the deposit. Any amount paid in addition to the booking fee will be refunded for cancellations up to 30 days before the ceremony. For cancellations within 29 days of the wedding date, there will be no refund, and 100% of the payment will be forfeited.

We will gladly reschedule your wedding due to COVID-19 but if your original date has passed and you decide to cancel the new date there is no refund as we've held two dates for you.

However, if We Do...I Do's cancels the wedding, we will receive a 100% refund on all payments made.

Please READ and Initial

_____If we change the date/time of our wedding the following rules will apply: If We Do..I Do's have the new date/time available they will simply change the date/time and re-reserve it under the new date/time. However, if We Do..I Do's is already obligated for the new date/time and is unable to officiate our wedding on the new date/time, it will be considered a cancelation and the initial security deposit is forfeited and We Do..I Do's is relieved of all responsibilities set forth in this contract.

_____ I understand that a completed contract <u>and</u> payment must be received to reserve the date and time for our ceremony.

_____ Any fee or payment that is dishonored by our financial institution for any reason, we agree that there is an additional charge of \$50.00.

_____If your ceremony includes a sand ceremony, unity candle or any other special feature you are responsible for furnishing all equipment needed. We are more than happy to instruct you on what you need and where you can buy it but we do NOT provide the equipment.

______ Officiant will arrive at the Wedding address or location listed on the contract at the agreed upon time as listed on the contract for your rehearsal and/or your wedding ceremony. Couple understands that they must adhere to these times, we do understand weddings do not always go as planned and will accommodate for weddings that start a little later than scheduled. We allow approximately a 1 1/2 hour block of time per wedding to give you plenty of time and give room for unexpected delays. We may have to leave to attend another wedding if your wedding is delayed more then 40 mins beyond your scheduled start time. We do our very best to accommodate unavoidable delays.

_____Houston has the 5th worst traffic in the US, we plan our travel accordingly but we can not foresee unexpected traffic delays due to accidents or severe rain/flooding. We will contact you if we are unexpectedly delayed and give you our estimated time of arrival.

_____If you wish to have us attend your rehearsal it needs to be added to your contract, it is not included with a Customized Wedding ceremony. Also either Marty and/or Jeff will attend the rehearsal depending on our wedding schedule.

In the event that We Do...I Do's is unable to attend and perform the services as planned due to hospitalization, auto accident, transportation breakdown/disruption, traffic difficulties or other unforeseen incapacitation on the day of the ceremony, We Do...I Do's will send an alternate who will provide the same level of service, if we are unable to provide an alternate we will provide a 100% refund.

All parties agree that this Agreement is the sole binding agreement, relating to the performance or officiating of the Ceremony, between all parties involved and may only be altered, amended, or invalidated by a separate written agreement executed by all parties to this original agreement. No verbal, non-written, or other informal agreement shall apply or be held binding to either party.

This Agreement shall be governed by and shall be construed in accordance with the laws of the State of Texas.
