Greenhorn Creek Resort Banquet Policies - Terms & Conditions

CONFIRMATION/CANCELLATION POLICY

A deposit and signed contract is required to make reservations. Reservations are on a first-come first-serve basis. Reservations will not be considered confirmed unless the full deposit and signed contract are received. All deposits made are non-refundable. Any function canceled less than 120 days prior to the event date, will be subject to a cancellation fee in an amount equivalent to the minimum expenditure. Reimbursements, if any, will be at the discretion of the GHCR Management.

FOOD & BEVERAGE MINIMUM

All packages have a Food & Beverage minimum. This is the lowest dollar amount that must be spent on either food or beverages and does not include taxes, gratuity, or service/labor charges. Events that do not meet this minimum in food or beverages, will be charged for the remaining balance of the minimum.

PRICES & SERVICE CHARGE

Food prices are subject to change and will be guaranteed 90 days prior to your function. All food and beverage items and charges are subject to a 20% service charge in additional to Federal, State, and Local taxes.

PRICES & SERVICE CHARGE

All food must be supplied and prepared by GHCR and may not be removed from the premises. Ceremonial and birthday cakes are permitted as an exception. These menus serve only as a guide for planning your special event. Our food and beverage staff will be happy to create any custom menu that you may desire. We must receive all final menu selections, room arrangements and other details at least 30 days prior to your event. *To-go meals are not allowed, no exceptions.

BAR & BEVERAGES

Bar prices are subject to change and will be guaranteed 90 days prior to the event. Bartenders reserve the right to refuse service to anyone. Guests not complying with Federal and State laws regarding underage drinking may be asked to leave the premises. In accordance with State and Federal Regulations, all alcoholic beverages (with the exception of champagne and wine) must be consumed on the premises and be supplied by GHCR. Any liquor or alcoholic beverages brought into the resort will be confiscated and disposed of. Hosts may provide their own un-opened bottles of champagne and/or wine, each 750ml bottle is subject to a corkage fee.

GAURANTEED ATTENDANCE

30 days prior to the date of your function, you must provide our Event Coordinator with a guaranteed number of attendees. The guaranteed count provides the basis for charges and is not subject to reduction. In the event a guaranteed count is not submitted, either the estimated count or actual count will be used for billing, whichever is greater. Increases in guaranteed attendance are subject to food availability and/or approval by the Food & Beverage Manager.

RESPONSIBILITY OF HOST

The host of the event will be responsible for providing GHCR with an itinerary of events for the day including timelines, secondary contact information, location and length of the ceremony. As well as the names and phone numbers of your vendors in case of emergencies. The host is responsible for all guests invited to the event. This includes behavior, attire, and treatment of the staff. Anyone not following the rules will be asked to leave the premises.

OUTSIDE CONTRACTORS/VENDORS

All outside vendors must be pre-approved by our Event Coordinator at least 30 days prior to the date of the event. Your vendors and suppliers may enter the facility no sooner than 1 hour prior to the scheduled beginning time of your event unless other arrangements are made with our Event Coordinator. Your DJ must sign a decibel agreement form prior to your event.

DECORATIONS

GHCR does not assume any responsibility for any decorations. All displays, exhibits and decorations must conform to current fire and safety codes. GHCR does not permit anything to be affixed to the walls, ceiling, furniture or textures unless approved by our Event Coordinator. All decorating and removal must be done during regular hours and is the responsibility of the host. If the decorations remain after the pre-set time, the Resort will have them removed and the host will be charged a fee of \$500. Any damages to the Resort or GHCR property will result in non-negotiable additional charges and will be added to the final bill. All decorations, as well as methods or placement, must be approved by the Event Coordinator prior to the event. All belongings of the engager will be held up to 24 hours after the event and after 24 hours will be discarded unless prior arraignments have been made with our Event Coordinator. This includes but is not limited to wine, cake toppers, and decor.

FLORAL & CANDLES

All floral arrangements must be free-standing (no nails, staples or other attachments) and must not deface any of the GHCR properties. All floral arrangements must be fireproof, in compliance with fire and safety codes. Fresh flower petals are permitted on tables, however, should any decorations stain our linens, there will be a linen replacement charge added to the final bill. Glitter, confetti, rice and birdseed are not permitted. For the safety of persons and property, no open flame, no fireworks or incendiary devices may be used at the Resort. Outdoor events may not use artificial flowers unless affixed to a chair or arch, however real petals are permitted to be thrown.

BILLING

All payments must be provided 30 days prior to the event unless other payment arrangements have been made. GHCR accepts cash, check, cashier's check, money orders and all major CCs. All credit/debit card payments will be subject to a 3.4% administrative fee. Questions and concerns regarding event billing must be addressed immediately. Failure to pay within the allotted time with result in a late charge of \$250 or cancellation of event.

BILLING LIABILITY/DAMAGE OR LOSS OF PROPERTY

GHCR reserves the right to inspect and control all private functions. Any damages done to the property by guests, attendees, independent contractors or their agents under your control will result in replacement fees. These charges will be determined at the discretion of GHCR Management and are non-negotiable. GHCR will not assume responsibility for the client's personal property and/or equipment brought into the resort. GHCR will not assume any responsibility for damage or loss of any properties or articles left at the resort after the event.
