The Trial

A non-refundable/non-transferable retainer fee of 50% of trial services is required to reserve a trial appointment. Your remaining balance will be due the day of your trial appointment.

All trials are held Monday through Wednesday at our home studio located in Cortlandt Manor, NY.

Wedding Day Booking

50% of wedding day totals & signed contract are required to secure your wedding date. Retainer and contract are due within 2 days of created contract. All payments must be paid in one full payment by the client by Check or Zelle. Final balance is due 2 weeks before the wedding date. For any weddings booked within 3 months of date, payment is due in full and can not be canceled/refunded.

Once the contract is signed, services can only be added if available not subtracted.

No refunds will be given for retainer paid after the contract is signed. If you cancel your contract within 90 days of your wedding date, you are responsible for 100% of total due.

Additional Fees

For any weddings that begin before 7am, an early start fee of \$50/hr per artist will apply. Hotel/room accommodations may be required for each artist for any weddings that start before 8am with a 2+ hour travel time or due to inclement weather.

There is a \$200 fee per additional artist.
Please inquire about artists for your headcount.

There will be a \$500 fee for all holidays and holiday weekends. A \$150 fee per additional artist will apply. (ie: New Years, Memorial Weekend, Easter, Fourth of July Weekend/Day, Labor Day Weekend, Thanksgiving, Christmas and any other national holidays.

If you wish to change any information after the contract is signed, there will be a fee of \$50 per adjustment and contract, if our availability allows us to do so.

There is a late start and overtime fee of \$25 per half hour/per artist for any services that start later than expected start time and/or any services performed after the Expected End Time.

Client is responsible for all airfare, parking, tolls, lodging, and auto rentals when applicable.

There will be a \$100 fee per artist for any room/hotel relocation and any applicable added travel expenses.

Additional bride only touch ups are \$200/hr and will begin upon completion of services until your artist leaves. Relocation and additional travel fees may apply.
