



## BRIDAL SERVICE CONTRACT

This makeup service contract is made and entered into as of \_\_\_\_\_ (date)

signing this contract, both you and I are legally bound to the following terms:

**1. Makeup Artist's Obligation:** To provide services hereunder is subject to change/unavailability of the Artist as a result of sickness, accidents, acts of God and other reasons beyond the Makeup Artist's control.

**2. Allergies:** Client agrees to notify Makeup Artist of any allergies she/he may have towards cosmetics and/or chemicals. Should a reaction occur, requiring medical attention or not, it is agreed that the Makeup Artist is not legally liable or responsible for any injury and/or ailment of any kind.\*

**3. Bridal Service Options:** Choose one or more from the following options for your Bridal Services

**Bridal Trial - \$95:** This is a pre wedding service located at Eu'Nique Faces to create your flawless look for your Wedding Day.

**Bride - \$115:** This option is reserved for the wedding day and includes a bridal touch up kit. A one time travel fee is applied to on location brides.

**Bridal Entourage - \$100 per person:** There will be a total of \_\_\_\_\_ members of the bridal entourage (Excluding Bride) receiving makeup service. Each member of the bridal party must pay a \$25 deposit that goes towards their total \$75.

**Travel Fee - \$80:** This fee is for any locations within 40 miles of 77036. Any travels outside of 40 miles will require an additional travel fee that is determined by location unless otherwise disclosed by the Artist. For parties over 8, there will be an additional \$60 fee to cover the travel fee of the required assistant artist.

**A LA CARTE Service Options:** These options can be added to any of the above mentioned service options at the listed additional price.

**Touchups - \$50/hr:** Will you require additional time for touchups or to change your makeup? Additional time is available at \$50/hr for a minimum of 1 hour. The time begins immediately after the last person from the initial service has ended.  
*Number of hours Requested:*

**Relocation - \$60:** A \$60 breakdown/setup fee will be added for any parties that require the artist to relocate in between service time. Meaning, if the artist has to begin service at one location then pack up, and travel and set up at another location to complete the service.

**4. Additional Fees :** *Please initial next to each to agree to the listed terms*  
-Client is responsible for valet/parking fees incurred. \_\_\_\_\_  
-Client is responsible for any out of town travel expenses (i.e Flight/Hotel) for locations 2+ hours away from Eu'Nique Faces base location and/or destination weddings. \_\_\_\_\_  
-If the artist has to wait 30 minutes to begin working due to tardiness, failure to answer phone calls/texts to get an E.T.A. or any other occurrence at the fault of the client(s), the artist will leave and not return and no refunds will be issued. \_\_\_\_\_

**5. Payment:** A \$25 deposit is due for each person receiving services on the Wedding Day and half of your travel fee. Your deposit is due at the time you sign your contract to secure your date. ALL remaining balances must be paid 1 week prior to the event date. 1 invoice will be sent via Paypal to keep track of payments however all payments must be made via Paypal, Cash App, or Apple Pay.  
***Please note: Only 1 invoice will be sent to the bride for ALL services being performed. Once invoiced, it is the brides responsibility to ensure all payments from party members are received.***

**6. Photographs:** Client agrees to full use of photograph(s) taken during and/or after makeup services are provided by Eu'Nique Faces LLC for:  
- a. Makeup Artist Portfolio and/or promotional images (Instagram, Twitter, Facebook etc.)  
- b. I DO NOT want my photos used for ANY reason other than to be in the Makeup Artist's files.
