Fee(s) are paid by Check or paid by using your credit card on PayPal. Retainer/fee of \$250 or the full payment (\$150 for an elopement). If your wedding is 90 days from the current date, the FULL fee payment is due to secure the date in our schedule. We will invoice you for any outstanding balance. All balances are to be paid 90 calendar days before the ceremony.

No reservation is booked until a registration/contract is fully completed and retainer paid. Questions? Call us.

<u>If already legally married, then email a copy of your certified marriage license to us ASAP.</u> When already married the ceremony is a Vow renewal. However, we officiate a ceremony <u>that resembles a wedding ceremony.</u> We just "announce" you versus "pronounce you" from a legal position as husband and wife or Partners.

<sup>\*</sup>Note: If a catholic option is selected, certain rituals & rubrics need to be followed.

DEFINITION: The couple, <u>2 witnesses</u> . A couple travels to the Officiant to marry them usually 1-3 minutes. Elopement means a couple gets married suddenly and privately, usually in a hurried manner away from a couple's local residence for several reasons. Example; shipping out on Military Orders, family issues etc. thus an immediate need to get married. A couple must be of legal age to marry in any given State or Commonwealth.
