Officiant Services (Rev. Julián Bermudez):

- Includes prompt completion and return of your marriage license to the courthouse.

Standard Wedding or Renewal of Vows Ceremony* **\$100**

- Pre-scripted, wedding or renewal of vows ceremony (religious or secular) that contains the essential parts of a wedding ceremony to include: welcoming your family and guests, declaration of intent, exchange of vows, exchange of rings, pronouncement, and presentation of Bride and Groom.
- Can include some bilingual (English/Spanish) sections, such as welcoming your guests and family, pronouncement and presentation.
- Can include an on-site rehearsal of your ceremony, for an additional \$50.
- Includes prompt completion and return of your marriage license to the courthouse.

Basic Wedding or Renewal of Vows Ceremony* **\$50**

- Pre-scripted, short wedding or renewal of vows ceremony (religious or secular), for the couple only (no wedding party involved) that contains the main parts of a wedding ceremony, i.e., declaration of intent, vows, exchange of rings, pronouncement, and presentation.
- Includes prompt completion and return of your marriage license to the courthouse.

Day of the wedding, Laura, who is fully bilingual (English/Spanish) will:

- Assist Bride and Groom, their families and wedding party, to get ready for the ceremony.
- Will ensure a smooth flow of the ceremony from beginning to end, including organizing the Officiant, parents, Bride and Groom and wedding party.
- Greeting and directing seating of family and guests.
- Coaching and managing the ushers, lighting of candles, set-up of other props and materials, etc.
- Last minute orchestrating of Officiant, D.J., musicians, photographers, and videographer.
- Setting up and directing everyone through the Processional and Recessional.
- May attend and participate in the ceremony rehearsal (if one) to familiarize herself with entire flow.

Pre-Marital Counseling & Coaching: **\$100.00**

Marital Counseling: **\$25/hour**
