Welcome to the Coral Gables Golf and Country Club

The Coral Gables Golf and Country Club is a historic venue located in the heart of Coral Gables and an illustration of the City Beautiful movement.

Built in 1922, this iconic landmark developed by Coral Gables founder and visionary George Merrick was the first public facility built in Coral Gables designed to entertain prospective buyers from its distinctive tower while large crowds gathered and danced to music of renowned band leaders.

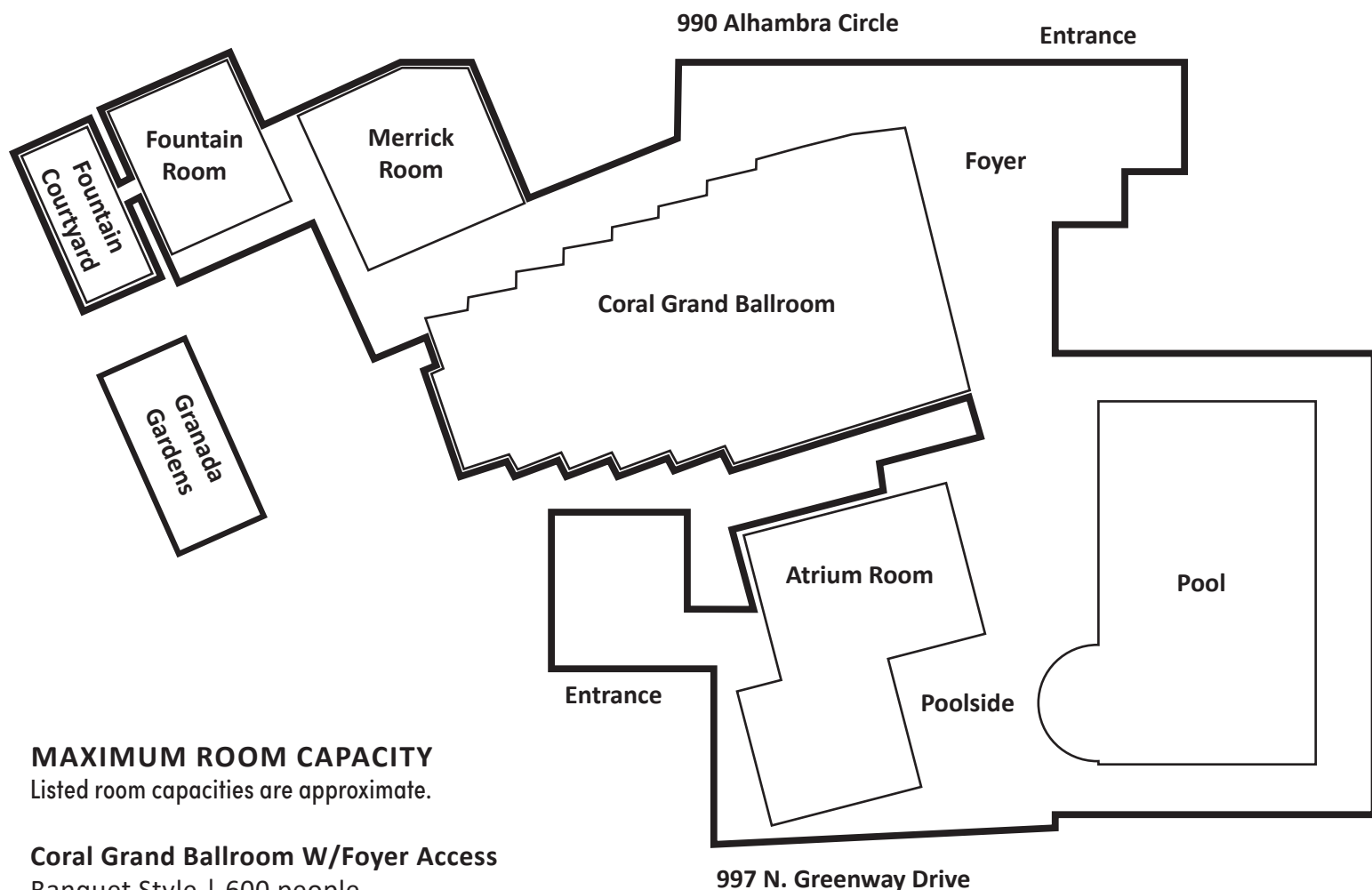
Today, this 40,000 square foot facility gracefully blends the traditional Mediterranean style of the exterior façade with classical interior finishes found throughout the elegant Coral Grand Ballroom and three similarly appointed event spaces.

Each space is unique and features elements of luxury and sophisticated elegance including stunning crystal chandeliers, impressive black marble foyers, rich Brazilian cherry hardwood floors, ornate Italian marble columns, and cornice moldings.

Whether planning an intimate gathering or an extravagant gala, the Club offers unsurpassed elegance in a variety of stunning indoor and outdoor settings to host a one-of-a-kind event.

In celebration of the Coral Gables Golf & Country Club's centennial anniversary, the venue has been restored and reopened for the community and future generations to enjoy.

Notes about rates and room capacity:

- All fees are subject to a 7% sales tax. Venue pricing is subject to change. All venue pricing is based on a five-hour event and a maximum per space guest count, with exception to the Granada Garden rental space, which is based on an hourly rate.
- All events are subject to a refundable security deposit of \$2,000 for daytime, or \$3,000 for evening events. The Rental Deposit is (daytime) \$1,000 (Evening) \$2,000 and the Music Sound Abatement Deposit \$1,000. These are refundable upon conclusion of the event within 30 days as long as the User is not otherwise in default.
- The user is responsible for the cost and procurement of all venue requirements in connection to the event.
- Room rates are based on the banquet-style event (Listed capacities are approximate): Grand Ballroom up to 300 guests, Atrium up to 100 guests, Fountain and Merrick up to 80 guests, and Granada Gardens up to 250 guests. Additional fees will apply for additional guests.
- Final price quotations for all categories can only be provided once event details have been determined.

VENDORS

Venue encourages use of the Country Club pre-qualified catering and vendor list. Use of non-listed vendors are subject to approval by venue and must comply with all venue logistics and insurance requirements. Client assumes liability for the use of non-registered vendors and may be subjected to additional fees.

CATERING

All caterers are subject to a separate food and beverage fee and must sign a catering agreement to be qualified and approved by the venue. Only venue-approved caterers will be permitted to cater any event on premises. Caterers must provide proof of insurance and name the City of Coral Gables as additional insured. A catering/alcohol license will be required.

No cooking of any kind, either open flamed or electric is permitted in the Atrium, Coral Grand Ballroom, Foyers, Fountain Room and Merrick Room. The venue requires final guest count guarantee 15 business days prior to the function date.

LOAD IN/LOAD OUT

Vendors will be given access to begin load-in and set-up four hours prior to contracted event time. Additional hours may be provided upon request and availability. Load-out is to commence immediately upon conclusion of the event and must be completed no later than three hours thereafter. Load-outs exceeding the allotted three hours may be subject to an additional hourly fee.

Load-in and load-out schedules must be submitted to the venue no less than seven days prior to the event. Approval for load-in and load-out schedules will be necessary to finalize vendor schedules. All vehicles participating in load-in must arrive and depart the property as scheduled.

ADVANCE DELIVERY & LATE PICKUP

All deliveries must be scheduled during the allotted delivery times. Deliveries will not be permitted in advance of the event date.

Late pickups of any item(s) will not be permitted. Item(s) left at the venue following the conclusion of the event are not the responsibility of the venue and may be subject to a \$250 daily storage fee. Item(s) left for more than 24 hours following the event will be disposed of at users' expense. The venue will not be responsible for setting up or removing any items.

SMOKE & FIRE

No fog, smoke, mist machines, fireworks or special effects will be permitted without written consent of the venue. Use of such equipment may require an additional City of Coral Gables permit(s) and is subject to additional fees and inspections. All required permits and associated fees will be the responsibility of the user. All emergency exits must remain clear and unobstructed.

ANIMALS ON SITE

With exception to service animals, pets may only be permitted in designated outdoor venue areas following venue approval. Damages incurred by any animal will be deducted from the security deposit. The venue reserves the right to recover all damages to property during user's event.

PARKING

The venue includes limited complimentary on-site parking. Cars can not park on the residential swale or on the golf course along North Greenway Dr. All guests are to obey all local laws regarding parking, or they may be ticketed and/or towed. For larger events, valet services are required. Entrance for Atrium is located at 997 North Greenway Drive. Entrance for Coral Grand Ballroom, Merrick and Fountain Room are located at 990 Alhambra Circle.

CLEANING & TRASH DISPOSAL

Venue and kitchen areas must be left in "broom swept" condition and garbage disposed of in designated disposal areas. All events are subject to a cleaning fee to ensure the facility is returned to its pristine condition immediately following the event. Birdseed or confetti are not permitted unless authorized by the venue and may be subject to additional cleaning charges.

RESTROOM ATTENDANTS

All events are subject to a restroom porter fee based on guest count for the duration of the event. Events up to 100 guests require a minimum of 1 porter per hour. Events up to 300 guests require a minimum of two porters per hour. Porter services for events above 300 guests will be assessed based on event requirements. Extended event times or the need for additional attendants may be subject to additional restroom porter fees at the expense of the renter.

COUNTRY CLUB PRESERVATION FEE

The preservation fee provides for a capital funding mechanism to preserve the historic integrity of the property and to maintain the property's aesthetics. This is a fixed fee.

ADDITIONAL FEES

The use of an hourly security guard is required for evening events and will be assessed at an hourly rate for the duration of the event. Depending on the event type or complexity, off-duty police may be required.
